- I. President Levy called the meeting to order at 6:31 p.m. in the Board Room of the David P. Meaney Education Center, Sacramento County Office of Education, 10474 Mather Boulevard, Mather, California. Board members present were Joanne Ahola, Alfred Brown, Heather Davis, Harold Fong, Greg Geeting, Jackie Levy, and Brian Rivas. Also present were David W. Gordon, Superintendent and Secretary to the Board; Al Rogers, Deputy Superintendent; Teresa Stinson, General Counsel; Matt Perry, Robin Pierson, and Tammy Sanchez, Assistant Superintendents; Bill Mullen CSEA; other staff and visitors; and Carla Miller, Recording Secretary.
- II. Ms. Davis led the Pledge of Allegiance.
- III. On a motion by Mr. Fong and seconded by Mr. Geeting, the revised minutes of the Regular Board Meeting of December 13, 2016 were approved. Motion carried 6 ayes, 1 abstention (Rivas).
- IV. Ms. Davis moved to adopt the agenda. Mr. Brown seconded the motion, which carried unanimously (7 ayes).
- V. There was no official correspondence.
- VI.A. There were no requests for visitor presentations from the general public.
- VI.B. There were no requests for presentations from employee organizations.
- VII.A. Elmer Brown, SCBC Assistant, Adult Re-Entry Programs, was recognized and honored as the classified employee of the month for February.

Yahaira Martinez, SH Teacher, Special Education Department, was recognized and honored as the certificated employee of the month for February.

Superintendent Gordon reported on the following:

Today, in a mid-year Community School graduation, we honored 16 graduates – 11 of them who were able to attend. Most of them are from SCOE's Senior Extension program. This program is giving our youth more

time to earn their diplomas and more opportunities to succeed in life. He thanked Assistant Superintendent Matt Perry, Principal Lisa Alcalá, and Senior Extension teacher Craig Bradford for initiating this program. He also thanked the Sierra Health Foundation for hosting our graduation and for being such a great partner.

- Reminded everyone that on February 1, 2017, we are hosting the Sacramento County School Boards Association Dinner Meeting. The meeting begins in the Mather Room with registration at 5:30 p.m. and dinner at 6:00 p.m. The guest speaker will be Sacramento Mayor Darrell Steinberg.
- Reminded everyone about the following February events: the Academic Decathlon competition on Saturday, February 4, 2017 at Inderkum High School with the Super Quiz beginning at 3:45 p.m.; the Academic Decathlon Awards dinner on Wednesday, February 8, 2017, beginning at 6:30 p.m. in the Sac State Grand Ballroom; and the Sacramento County Poetry Out Loud competition on February 9, 2017 beginning at 12:30 p.m. at Rosemont High School. VIII.A. Mr. Geeting moved and Mr. Fong seconded adoption of the consent agenda. Motion carried unanimously (7 ayes). By such action, the Board:

VIII.B. Mr. Rivas moved and Mr. Brown seconded approval of the contracts as listed. Motion to approve the contracts carried unanimously (7 ayes).

VIII.C. On a motion by Ms. Davis, seconded by Mr. Geeting, and carried unanimously (7 ayes), the Board authorized staff to submit grant applications/service contracts and accept funding if awarded; and approved contracts, positions, and other expenditures associated with the grants as outlined in the proposed budgets as follows:

- VIII.D. Chair Greg Geeting of the Budget Committee provided introductory comments and moved to accept the Audit Report for Fiscal Year Ended June 30, 2016. Motion carried unanimously (7 ayes).
- VIII.E. Mr. Geeting moved and Mr. Brown seconded the motion to adopt Resolution 17-01 Authorizing the Temporary Interfund Transfer of Funds. Motion carried unanimously (7 ayes).
- VIII.F. Mr. Rivas moved and Ms. Ahola seconded the motion to approve proposed Board Meeting Dates for 2017-2018 as listed. Motion carried 6 ayes, 1 no (Fong).
- VIII.G. President Levy announced this was the Second Reading and Adoption of Revisions to Board Policy 6120.1 Title I Programs.

Chair Brian Rivas of the Policy Committee moved that the Board adopt revisions to Board Policy 6120.1 – Title I Programs. Motion carried unanimously (7 ayes).

- VIII.H. Dr. Matt Perry, Assistant Superintendent, presented the College Readiness Block Grant details for discussion.
- VIII.I. Deputy Superintendent Al Rogers introduced Curriculum Specialist Frank Pisi who provided a History/Social Science Framework/Civics Education update to the Board.
- IX.A. Mr. Fong asked if the Board President and/or Superintendent would agendize a resolution declaring SCOE as a safe haven. He also wished to know what the timeline would be for the next Student Focus Group.
- Mr. Geeting congratulated the students who participated in the community school graduation ceremony, Sierra Health Foundation for such a fabulous venue, SCOE staff who put on another terrific graduation event, and Al Rogers for his outstanding keynote address. He reported that there have been two meetings of the Personnel Commission since last we met. The Commission approved relative minor revisions to the job description for the position of Information Systems Analyst following a job study. The Commission also approved the proposed description for the new position of Project

Specialist I, Adult Education. This new position will handle a variety of tasks pertaining to the Adult Education Block Grant. The Commission also approved somewhat more extensive changes to the job description for Youth Development Program Coordinator following a job study. The Commission elected Helena Hurst as its chairperson for 2017, and Gail Mullen as vice chairperson. On February 1, we have the Sacramento County School Boards Association meeting, but earlier that day, we have the opportunity to attend the African American Achievement Summit sponsored by Fortune School as a celebratory event to commemorate the beginning of Black History Month. There's a rally on the South Steps of the State Capitol at 10:00, followed by a Town Hall meeting from 1:00 to 3:00. The Winter 2016 issue of The Concord Review has been released and this issue includes one article from a California student, Johannes Nehemiah Hui of San Jose, concerning the historical causes of internal population movement within China and the present-day socio-economic impacts of that population movement. Another extremely interesting article by Ishwar Mukherjee, a student at Scarsdale High School in New York, concerns the development and the tremendous impact on all Americans of our country's largest company in terms of assets. This company maintains a portfolio of \$3.25 trillion. In terms of assets, it's bigger than Apple and Wal-Mart. It's the Federal National Mortgage Association, Fannie Mae. And, finally, an article by Benjamin Henly Wittenbrink of Chicago, discusses George Mortimer Pullman, the town he created (Pullman, Illinois), and the Pullman Strike of 1894, which was a watershed development in the strengthening of the labor movement in America.

BACKGROUND:

Governor Brown signed SB 828 into law during June 2016 authorizing the allocation of a \$200 million College Readiness Block Grant (CRBG) in the 2016-2017 fiscal year. The CRBG was established for the purpose of providing California's high school pupils additional supports to increase the number who enroll at institutions of higher education and complete an undergraduate degree within four years.

CRBG funds were preliminarily allocated at approximately \$149 per 9-12 student. LEAs with less than 500 9-12 students on census day received a base allocation of \$75,000. SCOE received a base allocation.

"As a condition of receiving these funds, a school district, county office of education, or charter school is required to:

- Develop a plan describing how the funds will increase or improve services for unduplicated pupils to ensure college readiness [EC section 41580(e)].
- The plan shall include information regarding how it aligns with ..., the county superintendent's local control and accountability plan (required pursuant to EC section 52066),
- The plan shall also include a description of the extent to which all pupils within the school district, county office of education, or charter school, particularly unduplicated pupils, as defined in EC sections 42238.01 and 42238.02, will have access to A-G courses approved by the University of California (EC section 41580(e)).
- In order to ensure community and stakeholder input, the plan shall be discussed at a regularly scheduled meeting by the governing board of the school district, county board of education, or governing body of the charter school and adopted at a subsequent regularly scheduled meeting. [EC section 41580)].
- On or before January 1, 2017, LEAs are required to submit information to the Superintendent, on how the LEA will measure the impact of funds received on their unduplicated pupils' access and successful matriculation to institutions of higher education, as identified within their plan. [(EC section 41580(f)]."

SUPERINTENDENT'S RECOMMENDATION:

The Superintendent recommends the Board adopt the proposed SB 828 – College Readiness Block Grant plan which, as required, was shared at a meeting of the SCOE governing board on January 17, 2017.

SCOE College Readiness Block Grant (CRBG) 2016-2017

The SCOE CRBG plan was established for the purpose of providing additional support to SCOE court school, community school, and Palmiter students with the goal of increasing the number who enroll at institutions of higher education and complete an undergraduate degree within four years.

CRBG funds were preliminarily allocated at approximately \$149 per 9-12 student. LEAs with less than 500 9-12 students on census day received a base allocation of \$75,000; SCOE received the base allocation.

When adopted, the SCOE CRBG budget will provide funding through June 30, 2018.

As a condition of receiving CRBG funds, SCOE has developed a plan describing how these funds will increase or improve services for unduplicated pupils, to ensure college readiness.

The plan includes information regarding alignment with the SCOE LCAP.

This plan was developed with input from principals, counselors, faculty, SCOETA, staff, CSEA, and interviews with students. We have included input from our non-profit and probation partners who have a rich history of helping our students with college readiness.

In order to provide the opportunity for community and stakeholder input this plan was included as an informational item for discussion at SCOE Board Meeting on January 17, 2017.

The CRBG plan, with suggested amendments from the January 17, 2017 Board Meeting is being presented as an action item on the February 7, 2016 Board Agenda.

The accountability system focuses on continuous improvement for all court and community schools operated by the Sacramento County Office of Education (SCOE) by evaluating multiple measures. The system sets up a methodology to continuously monitor and modify programs and strategies to enable all students to progress to their fullest potential.

Features of the Accountability System

- Relies primarily on existing reporting mechanisms and testing programs in order to minimize the data collection and reporting burden for schools;
- Measures performance through multiple indicators that are valid and reliable, yet appropriate for high-risk student populations;
- Compares a school's performance over time to itself rather than to other schools because of the unique characteristics of the court and community schools; and
- Applies the same indicators to measure the progress of each court and community school
 providing consistency and continuity for students who attend both types of schools.


Overall Design and Structure

The overall design and structure of the accountability system includes five indicators of school performance: one learning readiness indicator, three academic achievement indicators, and one educational transition indicator:

- 1. The **Learning Readiness** indicator will measure student participation in the learning process.
- 2. The **Academic Achievement** indicators will measure the academic progress a student makes in the core content areas of reading and mathematics and evaluate the number of credits earned by the student while enrolled in a court or community school.
- 3. The **Educational Transition** indicator will measure successful educational accomplishments.

Quarter totals for these indicators are cumulative from the beginning of the school year to show progress toward the year-end goals.

Strategies for Improvement

El Centro – We will conduct an analysis of quarter one student absences; to determine why we have a persistent three percent absent rate. Due to the incredible consistency of this rate; we should have the opportunity to determine what factors contribute to absenteeism and what we can do to improve attendance.

Hickey – Continue to reach out to families to encourage daily attendance. Continue to reward and acknowledge great attendance at award assemblies.

North Area – The Principal will work with students, families, and Probation to determine if any additional supports will improve student attendance. We are developing a partnership with the Hawk Institute to provide additional community support, mentoring, and weekend self-improvement workshops for students at NACS.

Gerber – Continue to reach out to families to encourage daily attendance. Continue to encourage and reward students daily, weekly, and monthly.

Strategies for Improvement

El Centro – Continue to provide interventions in math for all students. Interview El Centro staff with math expertise to determine which of their successful strategies show promise for community school implementation.

Hickey – Principal and math faculty will analyze math post-test scores by individual students showing no growth. Students not showing growth will receive support and individualized interventions. Hickey will implement a new model of daily intervention by Transition Specialists for students showing no growth. Hickey missed meeting the target by 5 students.

North Area – Continue to provide interventions in math across units. Interview NACS math staff to determine strategies that show promise for additional community school implementation.

Gerber – Principal and math faculty will analyze math post-test scores by student to determine why growth didn't occur. Students not showing growth will receive targeted interventions. Principal and staff will develop a plan with students to provide targeted math interventions on a daily basis. One of our partnering non-profits, Target Excellence, has secured a grant to support student achievement within the community schools, they are finalizing plans to begin providing support at Gerber Jr./Sr. High School. Gerber missed meeting the target by three students.

Strategies for Improvement

All Sites -

Sites are not meeting reading targets within a range of 0.8 students to 6.7 students per site.

Principal and math faculty will analyze reading post-test scores by individual student to determine why growth didn't occur. Students not showing growth will receive targeted interventions. Students at Hickey will receive daily support from Transition Specialists, NACS is developing a new support structure with the Hawk Institute and Gerber has a new support partnership with Target Excellence.

Principal and staff will develop a plan with students and staff to provide reading intervention on a daily basis.

During February of 2017, all schools will pilot Read 180, SCOE's recently adopted intensive intervention program.

Each site is analyzing growth on Accelerated Reader assessment scores, to determine if students are showing reading growth on Accelerated Reader assessments vs. Ren Learn assessments.

Strategies for Improvement

El Centro, Hickey, and NACS – Principals and faculty will work to determine which students need to improve credit accumulation to make sufficient progress. Targeted supports and encouragement will focus on this group of students.

At each school site not meeting target 23% – 50% of students are earning 7 to 9 credits per 30 days of enrollment. We will develop strategies to help this group improve their credit accumulation by 1 to 3 credits per 30 days of enrollment.

Gerber – Assistant Superintendent Perry will work with the Gerber team to determine what strategies are helping the school meet credit accumulation goals. Findings will be shared with other community school sites and implemented where possible.

Strategies for Improvement

All Sites – Continue targeted, intentional support throughout the program to encourage graduation, equivalency completion, and follow-through concerning re-enrollment when students return to district. Continue "return-to-district conferences" on community school sites or at district placement offices. Continue to follow up immediately if students do not show up for enrollment appointments.

Director Aland and Assistant Superintendent Perry recently visited all Sacramento County districts with secondary students enrolled in our community schools. Each district commented that they are receiving a high degree of communication and data regarding returning students and that they believe this in contributing to the high positive transition rate.

BACKGROUND:

Attached are proposed revisions to Board Policy 6173 – Homeless Education. All proposed revisions are indicated by strikeouts and bold underlined additions.

A brief summary of the rationale and basis for the proposed revisions follows:

 Policy changes are proposed to reflect recent changes to the McKinney-Vento Homeless Assistance Act.

The Policy Committee reviewed Board Policy 6173 – Homeless Education on November 15, 2016 and January 17, 2017, and recommended that the revised policy be presented to the Board for First Reading.

SUPERINTENDENT'S RECOMMENDATION:

The Superintendent concurs with the recommendation of the Policy Committee that Board Policy 6173 – Homeless Education be submitted to the Board of Education for First Reading.



HOMELESS EDUCATION

BP 6173

(Page 1 of 4)

Sacramento County Office of Education (SCOE) shall provide opportunities for pupils experiencing homelessness to meet the same challenging academic standards that all pupils are expected to meet. The Superintendent or designee shall identify and remove any barriers to the identification and enrollment of homeless pupils and the retention of homeless pupils including those due to absences or outstanding fees or fines.

The Superintendent or designee shall designate a person as the Sacramento County Office of Education (SCOE) liaison for homeless children and youth to assist with access to SCOE's education and services. The liaison will ensure that public notice is disseminated regarding the rights of pupils experiencing homelessness.

Enrollment

Education placement decisions for SCOE pupils experiencing homelessness shall be based on a pupil's best interest as defined by law.

SCOE pupils experiencing homelessness shall not be segregated into a separate school or program based on their status as homeless and shall not be stigmatized in any way. However, the Superintendent or designee may separate homeless pupils on school grounds for short periods of time for health and safety emergencies and to provide temporary, special, and supplementary services to meet the unique needs of homeless pupils.

They Pupils experiencing homelessness have a right to continue at or enroll in SCOE's community schools and at other SCOE school sites if they are otherwise eligible. A school site will enroll the homeless child or youth, even if the child or youth: 1) is unable to produce records normally required for enrollment, such as previous academic records, records of immunization, and other required health records, or other documentation; or (2) has missed application or enrollment deadlines during any period of homelessness.

Information about a homeless pupil's living situation shall be considered part of a pupil's educational record, subject to the Family Educational Rights and Privacy Act, and shall not be deemed to be directory information under the Act.



HOMELESS EDUCATION

BP 6173

(Page 2 of **4**)

Transfer of Coursework/Graduation Requirements

Pupils in homeless situations shall be entitled to the transfer of credits for coursework successfully completed, including partial credits, consistent with BP 6173.1 and BP 6146.3. When a homeless pupil who may qualify for an exemption from SCOE's graduation requirements transfers into a SCOE program, SCOE will within 30 calendar days of the pupil's transfer notify the pupil, educational rights holder, and SCOE homeless liaison of the availability of the exemption and whether the pupil qualifies for it. (See BP 6146.1 – Graduation Requirements.)

SCOE will use its Uniform Complaint Procedures (ARR 1312.3) to investigate and resolve complaints that SCOE has not complied with requirements regarding the transfer of credits or the exemption of local graduation requirements for homeless youth.

Services

Each homeless pupil shall be provided services that are comparable to services offered to other pupils in the school, including, but not limited to, transportation, educational programs for which the pupil meets the eligibility criteria (such as federal Title I services or similar state or local programs, programs for pupils with disabilities, and educational programs for English learners), career and technical education programs, and school nutrition programs.

When a parent or guardian of a pupil who becomes homeless requests that transportation be provided, SCOE shall arrange for transportation for a pupil to a SCOE school for the duration of homelessness to the extent required by law. When appropriate, SCOE will arrange transportation in consultation with the school district(s) in which the pupil is located.

The Superintendent or designee shall coordinate with other agencies and entities to ensure that homeless pupils are promptly identified, ensure that homeless pupils have access to and are in reasonable proximity to available education and related support services, and raise the awareness of school personnel and service providers of the effects of short-term stays in a shelter and other challenges associated with homelessness.



HOMELESS EDUCATION

BP 6173

(Page **3** of **4**)

The Superintendent or designee shall collaborate with local social services agencies, other agencies or entities providing services to homeless children and youth, and, if applicable, transitional housing facilities. In addition, the Superintendent or designee shall coordinate transportation, transfer of school records, and other activities with other local educational agencies. When a person who is experiencing homelessness also has a disability, the Superintendent or designee shall coordinate services as required by law within the SCOE programs and with other involved local educational agencies.

Pupils enrolled in a SCOE program who become homeless have the right to continue at the same program site as long as they are eligible for the program.

<u>Liaison</u>

The Superintendent shall designate a staff person as the SCOE liaison for homeless children and youth to assist with access to SCOE's education and services. The liaison shall fulfill the duties specified in 42 USC § 11432 to assist in identifying and supporting homeless pupils to succeed in school.

<u>Liaisons and other appropriate staff shall participate in professional development and other technical assistance to assist them in identifying and meeting the needs of homeless pupils and in understanding the definitions of terms related to homelessness as used in applicable laws.</u>

Board Reports

Annually, the Superintendent or designee shall report to the Board on outcomes for pupils experiencing homelessness, which may include, but are not limited to, school attendance, achievement test results, promotion and retention rates, graduation rates, suspension/expulsion rates, and other outcomes related to any goals and specific actions identified in the Local Control and Accountability Plan.

Dispute Resolution Process

SCOE shall assist in resolving school district disputes regarding school selection and enrollment of homeless children and youth pursuant to the resolution process developed by the California Department of Education. SCOE's procedures for resolving such disputes are in Administrative Rule and Regulation 6173.

BACKGROUND:

Attached are proposed revisions to Board Policy 5117 – Interdistrict Transfer Appeals. All proposed revisions are indicated by strikeouts and bold underlined additions.

A brief summary of the rationale and basis for the proposed revisions follows:

• Policy changes are proposed to reconcile the language of the policy with recent amendments to the Interdistrict Transfer Appeals Handbook.

The Policy Committee reviewed Board Policy 5117 – Interdistrict Transfer Appeals on January 17, 2017, and recommended that the revised policy be presented to the Board for First Reading.

SUPERINTENDENT'S RECOMMENDATION:

The Superintendent concurs with the recommendation of the Policy Committee that Board Policy 5117 – Interdistrict Transfer Appeals be submitted to the Board of Education for First Reading.



INTERDISTRICT ATTENDANCE TRANSFER APPEALS

BP 5117

(Page 1 of 3)

Pursuant to Education Code (EC) section 46601 et seq., the Sacramento County Board of Education (Board) shall hear and resolve interdistrict attendance transfer appeals for pupils in grades K-12, that which involve districts in Sacramento County. The Board shall also hear and resolve interdistrict attendance transfer appeals that involve a school district located in a different county if the Board has jurisdiction over the district that denied or refused to issue an interdistrict attendance a permit allowing the interdistrict transfer. If both school districts deny the permit or refuse or fail to enter into an agreement, the Board shall have jurisdiction over the appeal if the school district within the county is the pupil's district of residence.

The appeal shall be filed in writing, by a person having legal custody of the pupil, within 30 calendar days of the district's failure or refusal to issue a permit or to enter into an agreement allowing the interdistrict attendance transfer of a pupil in grades K-12. Failure to appeal within the required time will result in denial of the appeal unless good cause is shown. The appeal shall be accepted only upon verification of the Sacramento County Superintendent of Schools (Superintendent) or designee that all district remedies in the matter have been exhausted.

In an effort to make interdistrict attendance <u>transfer</u> appeal procedures understandable to parents, guardians, pupils and school districts, the Superintendent shall establish criteria and procedures to govern interdistrict <u>attendance</u> <u>transfer</u> appeals through Administrative Rules and Regulations (ARR).

Although the law allows discretion by the Board to determine whether to grant or deny an interdistrict attendance agreement transfer request on appeal, the Board's decision will be guided by the criteria set forth in the Interdistrict Transfer Appeal Handbook (ARR 5117). It is the responsibility of the person filing the appeal to provide facts which meet one or more of the criteria. Even if such facts are submitted, the Board will also consider any adverse impacts to the school districts in question and balance the competing factors.

If the written appeal is complete and appropriate, the appeal will be placed on the Board's agenda for a regular or special meeting to be held within the time period required by law. The Board or the Superintendent may extend this time period an additional five school days for good cause. The person filing the appeal or school district may request a postponement of the hearing for good cause. This request must be filed in writing at least five calendar days prior to the hearing date, except for an emergency.

The Superintendent or designee shall provide adequate notice to the person filing the appeal and the applicable school districts of the date and time of the appeal hearing as well as the opportunity to submit written statements and documentation.



INTERDISTRICT ATTENDANCE TRANSFER APPEALS

BP 5117

(Page 2 of 3)

The Board will render its decision within three school days of the hearing, unless the person filing the appeal requests a postponement. On a motion to grant the appeal, at least four members of the County Board must vote in favor for the appeal to be granted. Unless at least four members vote to grant the appeal, the appeal is denied.

If the Board grants the appeal, the pupil shall be admitted to school in the requested district without delay. The Board will not determine the specific school within the requested district where the pupil will be enrolled. This authority is reserved for the school district of attendance, after the Board grants the appeal.

Written notice of the Board's decision shall be delivered to the person filing the appeal and to the governing boards of the districts.

BACKGROUND:

Attached is the proposed Board Policy 5146 – Married/Pregnant/Parenting Pupils.

A brief summary of the rationale and basis for the new proposed policy follows:

• This policy is proposed to reflect recently enacted statutory requirements.

The Policy Committee reviewed Board Policy 5146 – Married/Pregnant/Parenting Pupils on January 17, 2017, and recommended that the new policy be presented to the Board for First Reading.

SUPERINTENDENT'S RECOMMENDATION:

The Superintendent concurs with the recommendation of the Policy Committee that Board Policy 5146 – Married/Pregnant/Parenting Pupils be submitted to the Board of Education for First Reading.



BP 5146

(Page 1 of 4)

The Sacramento County Office of Education (SCOE) shall not discriminate against any pupil on the basis of the pupil's marital status, pregnancy, or a condition related to pregnancy, i.e., childbirth, false pregnancy, termination of pregnancy, or related recovery ("related condition").

For school-related purposes, a pupil under the age of 18 years who enters into a valid marriage shall have all the rights and privileges of pupils who are 18 years old, even if the marriage has been dissolved.

Education and Support Services for Pregnant and Parenting Pupils

Pregnant and parenting pupils shall retain the right to participate in any SCOE program for which they are otherwise eligible. The classroom setting shall be the preferred instructional setting unless an alternative is necessary to meet the needs of the pupil and/or the pupil's child.

If SCOE offers an alternate education program to pregnant pupils, it shall have educational programs, activities, and courses equal to those offered in the regular program. A pupil's participation in such programs shall be voluntary. SCOE may offer educational and related support services alone or in collaboration with community agencies and organizations to meet the needs of pregnant and parenting pupils and their children.

SCOE schools may require a pupil, based on pregnancy or a related condition to obtain certification from a physician indicating that the pupil is physically and emotionally able to participate in an educational program or activity if such a certification is required of all pupils with physical or emotional conditions or temporary disabilities requiring the attention of a physician.

Absences

SCOE schools shall grant a pupil a leave of absence due to pregnancy or a related condition for as long as it is deemed medically necessary by a physician. At the conclusion of the leave, the pupil shall be reinstated to the status held when the leave began.

Absences related to confidential medical appointments for pregnant or parenting pupils are excused absences. A parenting pupil may request exemption from attendance because of personal services that must be rendered to a dependent.

Reasonable Accommodations

When necessary, SCOE shall provide reasonable accommodations to pregnant and parenting pupils to enable them to access the educational program.

A pupil who is pregnant or has a related condition shall have access to any services available to other pupils with temporary disabilities or medical conditions.

SCOE schools shall provide reasonable accommodations to any lactating pupil to express breast milk, breastfeed an infant child, or address other needs related to breastfeeding. A pupil shall not incur an academic penalty for using any of these reasonable accommodations, and shall be provided the opportunity to make up any work missed due to such use. Reasonable accommodations include, but are not limited to:

- 1. Access to a private and secure room, other than a restroom, to express breast milk or breastfeed an infant child;
- 2. Permission to bring onto a school campus a breast pump and any other equipment used to express breast milk;
- 3. Access to a power source for a breast pump or any other equipment used to express breast milk;
- 4. Access to a place to store expressed breast milk safely;
- 5. A reasonable amount of time to accommodate the pupil's need to express breast milk or breastfeed an infant child.

Complaints

Any complaint of discrimination on the basis of pregnancy, marital or parental status, or reasonable accommodations shall be addressed through SCOE's Uniform Complaint Procedures (BP/ARR 1312.3). A complainant who is not satisfied with SCOE's decision may appeal the decision to the California Department of Education (CDE). If SCOE or the CDE finds merit in an appeal, SCOE will provide a remedy to the affected pupil.
